You are being invited to complete an online survey as part of a research study course being undertaken by a research team from the University of Hertfordshire, Oxford University Hospitals NHS Foundation Trust and Oxford University.

Please read the following information carefully before deciding whether to take part. Please ask if there is anything that is not clear or if you would like more information.

You are eligible to take part in this study if you are 18 or older and a physiotherapy student, support worker, physiotherapist or interested in the future of physiotherapy research.

The Study

The purpose of the study is to develop recommendations for the Chartered Society of Physiotherapy for the future and development of physiotherapy research and options for them to consider to implement.

What does taking part involve?

If you agree to take part in this study, you will be asked to complete an online survey/questionnaire. This survey/questionnaire will ask about physiotherapy research, how it should be supported, funded and developed and it will take you approximately 10-15 minutes to complete.

Do I have to take part?

No. It is up to you to decide whether or not to take part. You are free to withdraw from the study at any time and without giving a reason. If you choose not to take part, you do not need to do anything further.

Are there any benefits or risks for me if I take part?

There are no direct benefits for you from taking part although it is hoped the findings of the study help the inform the profession and that participants find taking part interesting.

All data from the study will be stored securely on the University of Hertfordshire One Drive cloud storage system to which only the team have access. Anonymised data will be stored for three years in case the CSP have any additional queries during their review of pre-registration physiotherapy and then destroyed.

What will happen to the findings of this study?

The findings of this survey and additional stages of the wider research project will be used to help the team develop evidence recommendations for the CSP.

Has this study received ethical approval?
